TERMS & CONDITIONS OF SALE

- 1. ICOOL PACIFIC Pty Ltd (herein known as ICOOL PACIFIC) reserves the right to conduct credit and personal checks in accordance with the Privacy Act as part of the account application process. Any personal information gathered will remain confidential at all times.
- 2. Prices will be those ruling at the date of delivery unless quoted specifically on ICOOL PACIFIC official quotation.
- 3. Payment terms are strictly 30 days EOM from the Statement, unless specifically stated in the ICOOL PACIFIC official quotation. Payment terms on Indent orders will be stated separately on the ICOOL PACIFIC official quotation. ICOOL PACIFIC reserves the right to refuse to deliver any goods until all outstanding amounts are paid in full. Interest and administration fees at 1.5% per month of the overdue amounts may be charged at ICOOL PACIFIC 's discretion.
- 4. Ownership of all goods shall not pass to the buyer (and the buyer will be a bailee only in respect of such goods) until the buyer shall have paid all monies owing to ICOOL PACIFIC or any other related company thereof whether in respect of the purchase of price or contingently or otherwise howsoever. Until such time the buyer shall store all goods delivered by ICOOL PACIFIC in such a way that it is clearly the property of ICOOL PACIFIC.
- 5. Prior to buyers acquiring property in any goods, ICOOL PACIFIC may at any time directly or indirectly or by its agents or servant, enter upon any land, premises or property where it believes such goods may be to view and inspect the same and in the event of default by the buyer (including without limitations default in payment of any monies to ICOOL PACIFIC) to take repossession thereof.
- 6. Notwithstanding that property in any goods may remain with ICOOL PACIFIC, all risk in respect thereof shall pass to the buyer on delivery.
- 7. All pricing is subject to change at the discretion of ICOOL PACIFIC, reasonable notice will be provided in writing.
- 8. ICOOL PACIFIC takes no responsibilities of inability to supply requested goods and in no way guarantees stock of any item.
- 9. Any discrepancies or damage of goods shipped must be reported to ICOOL PACIFIC in writing within 24 hours from receipt of goods.
- 10. Any agreement pursuant to these terms and conditions shall in all respects be construed in accordance with and be governed by the laws of Australia and its territories. This agreement is governed by the laws of the state in which the goods were ordered.
